A BILL

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Arctic Refuge Protec-

- 6 Section 20001 of Public Law 115–97 is hereby re-

- 8 SEC. 3. DESIGNATION OF ADDITIONAL WILDERNESS, ARC-
- 9 TIC NATIONAL WILDLIFE REFUGE, ALASKA.
- 10 (a) Designation.—Notwithstanding any other pro-
- 11 vision of law, a portion of the Arctic National Wildlife Ref-
- 12 uge in Alaska comprising approximately 1,559,538 acres,
- 13 as generally depicted on the map entitled "Arctic National
- 14 Wildlife Refuge, Coastal Plain Proposed Wilderness",
- 15 dated October 20, 2015, labeled with Map ID 03–0172,
- 16 and available for inspection in the offices of the Secretary
- 17 of the Interior, is designated as a component of the Na-
- 18 tional Wilderness Preservation System under the Wilder-
- 19 ness Act (16 U.S.C. 1131 et seq.).
- 20 (b) Administration.—The Secretary of the Interior
